PROCESS & TIMELINE

1st MONTH



STEP 1

- Client executes retainer agreement. Advisory and due Diligence fees are due at this stage.

2nd to 3rd MONTH



STEP 2

- File preparation and submission. Government's Citizenship by Investment Unit issues Approval Letter subject to due diligence. Investment is to be made in selected option. Payment of government fees if applicable.

4th MONTH



STEP 3

- Naturalization Certificate is issued. Submission of Passport application. Passport issued.

OVERVIEW OF THE COUNTRY:

The Commonwealth of Dominica is known as the 'Nature Island of the Caribbean' due to its wide variety of flora and fauna and extensive natural park system. Much of the island is covered in rainforest and there are hundreds of waterfalls, rivers and lakes whilst also boasting world-class hiking experiences in its numerous nature reserves.

Dominica offers a fast route to citizenship of this peaceful, tropical paradise through its Citizenship by Investment Program. This highly reputable program has been operating since 1993 and is legally entrenched in Dominican law. Dominica has already granted thousands of second passports. Dominica is a member of the UN, the British Commonwealth, the Organization of American States (OAS) and CARICOM.



TWO TYPES OF INVESTMENT:

PROGRAM 1-DONATION OPTION

Non-Refundable Donation to the country's government fund (Economic Diversification Fund, EDF) starting from USD 100, 000 for a single applicant or USD 200,000 for a family of 4.



PROGRAM 2- REAL ESTATE OPTION

Government Approved Real Estate investment in Dominica which may be resold after 3 years or 5 years (If being resold to be used in another citizenship by investment application for a new investor) only starting from USD 200,000.
